

### What is API - American Petroleum Institute?

American Petroleum Institute (API) was established in 1919 as a standard-setting association. API develops, maintain, and provide organizations with unanimous standards for the oil and gas industry. API has developed more than 700 standards to improve operational safety, environmental assurance and sustainability over the industry, particularly through these standards being adopted comprehensively.

The American Petroleum Institute (API) is the largest U.S. trade association in the field of oil and natural gas industry. It claims to represent corporations involved in production, refinement, distribution and many other aspects of the petroleum industry. The safety requirements particularly in oil and gas industry are very stringent as a minor deviation in the product / component can lead to a major catastrophe. The product quality and operational consistency are the prime parameters to avoid any safety related issue at the site. API Standards helps to improve the safety of industry tasks, guarantee the quality, help minimize expenses, diminish waste, and limit the confusion in an oil and gas industry.

### The API Standards includes

- API Spec Q1: Quality Management System for Manufacturing Organizations
- API Spec Q2: Quality Management System for Service Supply organizations
- API Monogram Program: Product Specific Technical Standards such as API 6A, API 6D,
   API 600, API 602, API 682, API 5CT, API 16C etc.

Note: In monogram license program, API Q1 and product specific requirements are applicable to the organization.

The documented information required for API registration

- The organizations scope
- The organizations Quality policy and Quality Objectives
- A Quality Manual
- Standard operating Procedures
- Records at individual process / department. E.g. Sales, Purchase, Production, Quality
   Assurance, Maintenance, Customer Service.

### Which Organizations are eligible for API Certification?

The organization manufacturing components and assemblies and supplying to oil and gas
industry can apply for API Q1 certification. Similarly, the organizations offering services
specially in oil and gas sector can apply for API Q2 certification. The monogram licensing
is applicable for the specific product range manufacturing in accordance with the
relevant API product specification. E.g. API 6A, API 6D etc.

### What is the difference between ISO 9001 and API Q1?

 The API Q1 specification establishes the minimum quality management system requirements for organizations that manufacture products or provide manufacturingrelated processes under a product specification for use in the petroleum and natural gas industry.



### How long does API certification last?

API Spec Q1, API Spec Q2, and APII Monogram License has 3 years of validity.

# Can API Q2 and ISO 9001 be merged together into one system?

Yes. Both share common elements. Since API Q2 is the more prescriptive of the two sets
of quality requirements, complying with API Q2 should be the initial focus, then adding
any additional requirements of ISO 9001.
