#### What is BSCI?

The amfori Business Social Compliance Initiative (BSCI) is a business-led initiative that monitors and assesses workplace conditions throughout the global supply chain. A BSCI audit performed by amfori assists a company in monitoring its supply chain to guarantee that all suppliers are treating workers ethically and ethically.

The Amfori Business Social Compliance Program BSCI is a business-driven initiative that assists organizations in meeting their obligations to enhance global supply chain working conditions. Organizations that are BSCI compliant band together under a single code of conduct, which aids them in their attempts to build an ethical supply chain by providing them with a development-oriented system that is applicable to all industries and sourcing nations. International conventions cited in the BSCI Code of Conduct include the Universal Declaration of Human Rights, the Children's Rights and Business Principles, the UN Guiding Principles for Business and Human Rights, and the OECD Guidelines.

Foreign Trade Association established the BSCI standard in 2003. (FTA). The goal of adopting this standard was to promote consistency and to bring together organizations who wanted to improve their social compliance and factory improvement. BSCI follows the notion of international labor standards, which safeguards the rights of workers. We have reached the globalization era, and all retailers and importers now source their goods from suppliers all around the world. However, many businesses do not follow the national labour rules, or the regulations that are in place are insufficient. To address these issues, the BSCI has developed a single code of conduct and a single implementation system

#### Which organizations are eligible for Amfori BSCI Audit Certification?

- Manufacturing units including sub-contractors (Subject to specific requirement and consent from the customer)
- Note : The amfori BSCI Code of Conduct can only be audited by organisations who actively supply amfori BSCI members. The audit must be requested and approved through the amfori BSCI platform by the amfori BSCI member in charge of the supplier.

- Social (Policies, Procedures and related documents)
