The GSV programme is a collaboration between industry thought leaders and decision makers to ensure that supply chains run smoothly and comply with multiple global supply chain security initiatives, such as C-TPAT (Customs Trade Partnership Against Terrorism), PIP (Partners in Protection), and AEO (Authorized Economic Operators), the WCO framework, and related security requirements.
