The standard is developed as a "total quality management" programme, and it covers both food safety and quality requirements that food firms must achieve in order to be certified.

The GFSI recognizes the standards, which are used globally and aim to decrease the need for multiple supplier audits by harmonizing international food safety standards. Many of the world's top retail companies, manufacturers, and food service organizations recognize BRC standards, granting the certificate bearer a worldwide mark of excellence.

BRC Global Standards instill confidence throughout the supply chain by assuring the standardization of quality, safety, and operational standards. Customers may be assured that their products are safe, legal, and of high quality because they set the standard for good manufacturing technique.
