The BRCGS is initially published in 2006, the standard is periodically reviewed upon, by referring to the feedback received from the respective stakeholders. Currently, Issue 4 of the standard is launched in 2020. It demonstrates the best practice & facilitate the continual improvement by creating a well-defined risk based product safety management systems.

However, it is not applicable to the broker who doesn't have their own storage as well as not applicable to manufacturer as it is covered in BRCGS for Food Safety for manufacturers.

- Documented Policy.
- Objectives to improve product quality, safety & legality.
- Process Flow Chart.
- Hazard & Risk Identification with HACCP.
- Prerequisite program procedures.
- Deviation records in accordance to standard.
- Control of Document procedure.
- Quality Plans.
- Product Defence & Product fraud prevention plans.
- Supplier approval procedure.
- Supplier Performance Review.
- Facility Management records.
- Procedure for maintaining the security of the vehicle.
