- Applicable to all schools, regardless of type, size and nature of educational services provided. (Pre-primary, Elementary, Secondary and Higher Secondary Schools)

What is the validity of the NABET certification?

- The validity of NABET certification is for a span of three years starting from the date of office assessment

Is NABET accreditation of schools, mandatory by law?

- No, it's voluntary but accredited bodies gets preference over non accredited bodies'
