Beyond the initial assessment, Ecovadis assessment offers TfS members and its suppliers a platform to monitor continuous improvements of the sustainability practices along the supply chain.

What are the document requirements for Ecovadis Sustainability Rating?

Ecovadis Sustainability Rating is based on CSR Corporate Social Responsibilities in regards to four parameters:-

- Environment
- · Labor and Human Rights
- Ethics
- · Sustainable Procurement.

What are the score requirement for Ecovadis Medal?

The criteria for scorecards published from 1st January 2024 are as follows:

- Platinum top 1% (99+ percentile)
- Gold top 5% (95+ percentile)
- Silver top 15% (85+ percentile)
- Bronze top 35% (65+ percentile)

How long is the validity period of your EcoVadis result?

12 months from after your scorecard has been published.



What is a CSR rating and how is it relevant to EcoVadis?

 CSR stands for corporate social responsibility which can be defined as a management concept in which businesses incorporate social and environmental issues into their operations. The service provided by EcoVadis is a paid one where a company assess their materials sustainability impact which is based on the documented evidence.

How does EcoVadis work?

- The EcoVadis assessment is a four step process
- Step 1-registration of your organization at the portal,
- Step 2-Submiting an updated questionnaire,
- Step 3-expert analysis of the data collected and
- Step 4-Your rating.

Who can apply for reassessment?

• Organizations with an expired scorecard organization that do not meet the minimum score requirement of their client/customer if new information needs to be incorporated.

What all is considered in EcoVadis?

 The EcoVadis Rating takes into account a wide range of non-financial management systems, such as environmental, labour and human rights, ethics, and sustainable procurement. Each business is assessed on material issues that are relevant to its size, location, and industry.

What are the score requirements for a company to be awarded EcoVadis badges?

- Committed: A minimum score of 45 (representing 'Good' performance in the EcoVadis methodology)
- Fast Mover: A score between 34-44 with a minimum 6-point improvement compared to the previous assessment in an 18-month period.

Note: Companies that earn an EcoVadis medal are not eligible for an EcoVadis badge.



360° Watch for Badges

A company is ineligible for a badge if,
 It has any severe finding(s) within the past 5 years for Environment, Labor & Human
 Rights, Sustainable Procurement themes or 7 years for the Ethics theme.

360° Watch for Medals

A company is ineligible for a medal if,
 The 360° Watch Indicator score = 0 for any theme or 25 for any two themes*

 *Large companies remain eligible for a medal if they only have 50 or fewer minor findings and/or only 1 major finding on the scorecard.
