

#### What is SBTi?

SBTi stands for Science Based-Targets Initiative. It is a collaborative effort between CDP (formerly the Carbon Disclosure Project), United Nations Global Compact (UNGC), World Resources Institute (WRI) and World Wide Fund for Nature (WWF). It provides a framework and methodology for companies to set science-based targets for reducing greenhouse gas (GHG) emissions.

#### What is the objective of SBTi?

The primary goal of SBTi is to align corporate emissions reduction targets with scientific evidence on climate change. By doing so, companies can contribute to global efforts in limiting global warming to well below 2 degrees Celsius above pre-industrial levels and pursuing efforts to limit it to 1.5 degrees Celsius, as outlined in the Paris Agreement.

By participating in the SBTi, companies can enhance their credibility, demonstrate leadership in climate action, and align their sustainability strategies with global climate goals. Additionally, SBTi plays a crucial role in driving corporate action towards a low-carbon economy and fostering collaboration among businesses, policymakers, and civil society to address climate change challenges collectively.

#### Who can take part in SBTi?

 Companies from all sectors and sizes are eligible to participate in SBTi. To facilitate this, SBTi has developed sector-specific guidance to assist companies to develop sciencebased targets. Organizations which have fewer than 500 employees are categorized as SMEs, which are also eligible for SBTi.

#### What is the process flow of SBTi?

The Process flow of SBTi is divided in 5 steps:

- Commit
- Develop targets
- Submit
- Communicate
- Disclose

#### What types of targets can be submitted on SBTi?

There are four types of targets available on Science Based-Targets Initiative for companies

to show their commitment to GHG emissions reduction:

- Near Term Target
- Net Zero Target
- FLAG Target
- Targets for Financial Institutions



#### How did SBTi evolve over the years?

- 2015: The SBTi is founded by CDP, the United Nations Global Compact, the World Resources Institute (WRI), and the World Wide Fund for Nature (WWF).
- 2017: The SBTi launches its first sector-specific guidance for the power sector.
- 2018: The SBTi announces that it will expand its target setting methodology to include all sectors of the economy.
- 2019: The SBTi launches its first Net-Zero Standard for companies that aim to achieve net-zero emissions by 2050 or sooner.
- 2020: The SBTi announces that it has reached its goal of having 100 companies with science-based targets.
- 2021: The SBTi launches its Net-Zero Standard for financial institutions.
- 2022: The SBTi announces that it has reached its goal of having 1,000 companies with science-based targets.

#### How should a company submit a target to SBTi?

In order to submit or update your targets, companies must fill out a Target Submission
Form and submit it on Target validation booking system.

#### Are there any criteria to set targets for SBTi?

• Yes, there are 28 criteria for setting Near-term and 37 criteria for setting Net Zero targets.

### What are the approved methods of disclosure for SBTi?

SBTi has defined the following method of disclosures as acceptable

- Disclosure via CDP
- Annual Reports
- Sustainability reports
- On Company's website.



#### What is the duration for targets?

• The duration for targets is 5 years at minimum and 10 years at maximum for Near-Term targets and year 2050 for Net-Zero target.

#### How can SMEs submit targets for SBTi?

• SBTi has created an exclusive streamlined process for target validation for SMEs, which allows them to bypass the initial commitment phase.

#### Is there a cost associated with SBTi services?

• There is a cost applicable for target validation services on SBTi, which vary as per the target submitted.
